

PROPERTY DESCRIPTION

Located between Austin and Battle Mountain in western Lander County, lies Antelope Valley farm. Equipped with 5 agricultural wells and 4 Zimmatic pivots, this beautiful 640-acre parcel produces high-quality alfalfa, much of which is exported.

The property includes a modest 1,620-square-foot manufactured home with three bedrooms and two bathrooms, a 680-square-foot detached garage, and a spacious 50 x 60-foot shop with a concrete floor.

Battle Mountain is 62 miles north on Interstate 80 and offers a clinic, hospital, airport, and basic amenities. With a population of about 4,200, the town hosts several events throughout the year, including a Basque festival and a Chukar tournament. More extensive ag services can be found in the larger towns of Winnemucca to the west and Elko to the east.

The farm is situated in game management unit 156 and is bordered by BLM land to the west. Northcentral Nevada offers a rich outdoor recreational tapestry and excellent hunting and fishing opportunities.

This 640-acre farm in western Lander County, Nevada, is a prime agricultural property with a strong production history. It features a comfortable home and ample storage and is conveniently located near essential services and outdoor recreational activities. 









Locator Map
