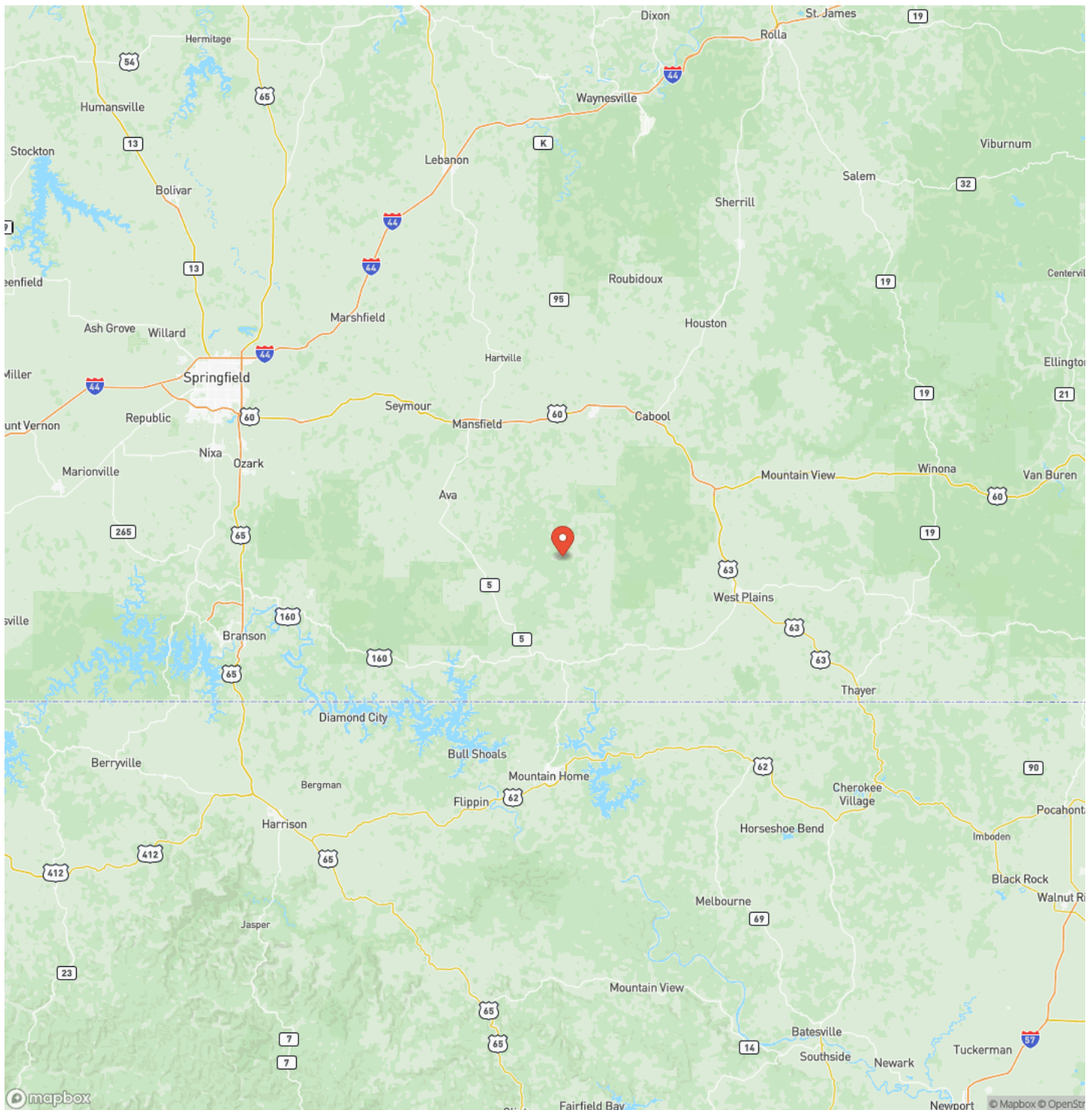

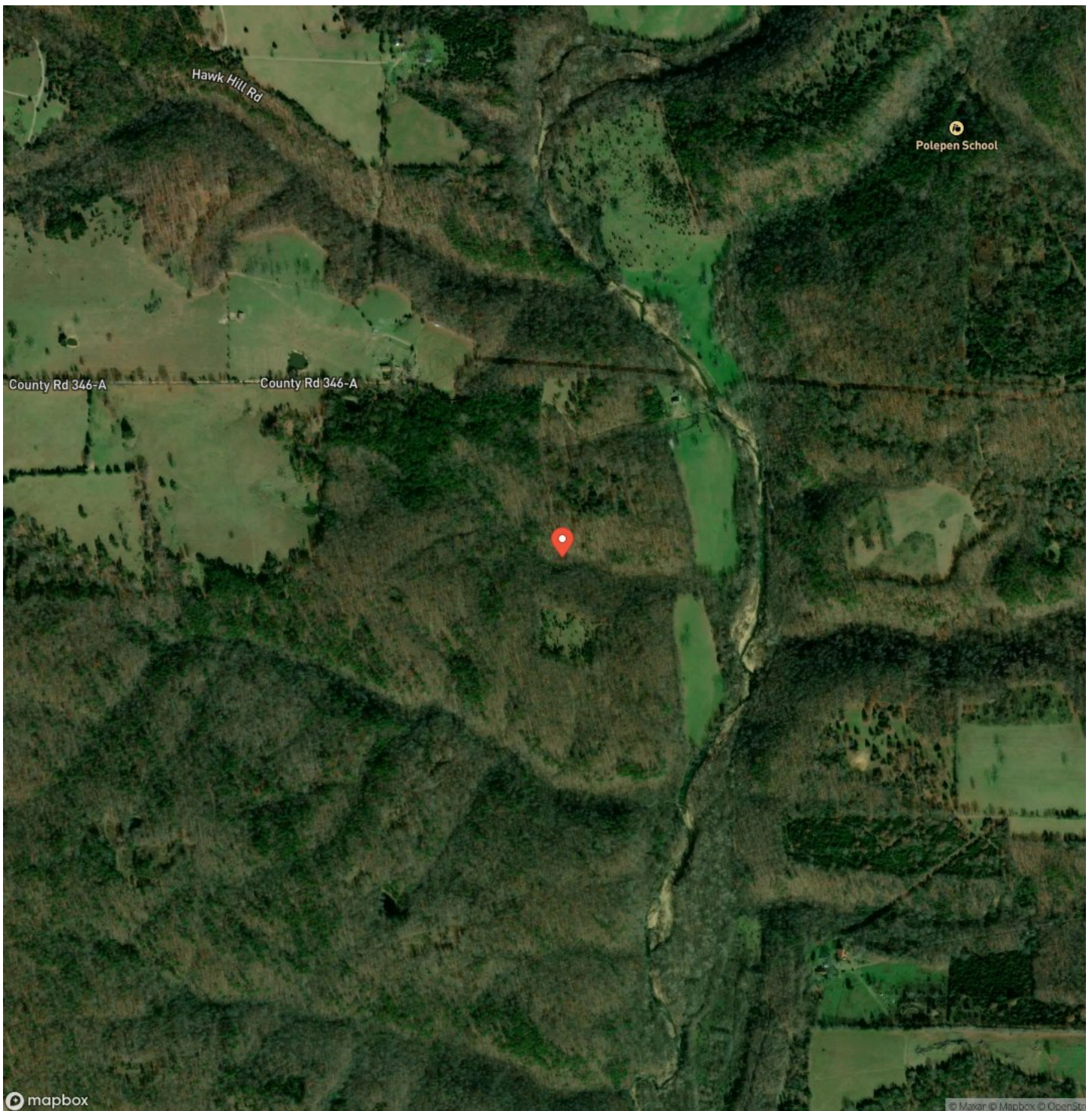
Locator Map
