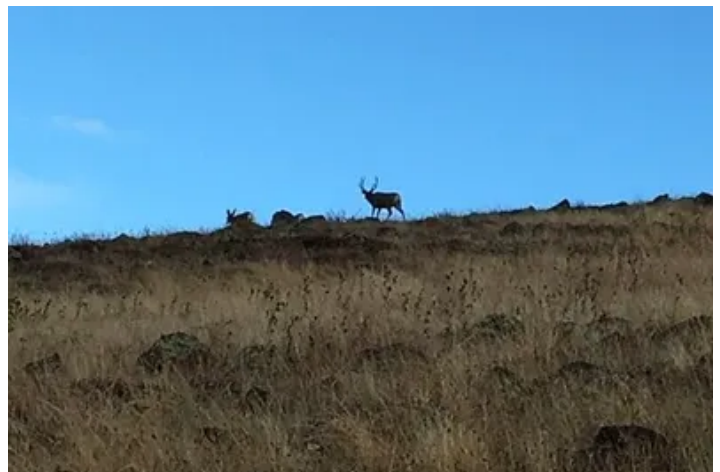

The opportunity has come to own the ultimate hunting and fishing property located in a very desirable area within Northeast Oregon. In one single day, you can harvest a trophy buck, a limit of multiple upland game bird species, and catch a limit of trout all without leaving the property. Top it off with tasteful improvements and you have the Imnaha River Ranch!

The Imnaha River Ranch is located on the picturesque Imnaha River approximately 9.5 miles South of the small town of Imnaha itself. The ranch is bordered by public lands to the East where Hells Canyon and the Seven Devils mountain range span for many miles until civilization starts again. Approximately forty miles away from the Imnaha River Ranch is the town of Joseph, OR which is famed for its beauty and many events/activities that happen there. Ride your UTV into the small town of Imnaha and have a burger at the famed Imnaha Store and Tavern where you can exchange hunting stories among all the other locals. Most everyone who witnesses this area dreams of owning land here!

The property is made up of approximately .55 miles of private river frontage with some great pockets for catching fish. Also on the ranch are irrigated hay fields, rolling grassy hills, and deep timbered draws. In addition to the Imnaha River, Schleur Creek, Spring Creek, Adams Creek, College Creek, and multiple springs provide abundant water resources supplying adequate water for game, livestock, and 88 acres of water rights. A road system provides great access throughout most of the ranch.

The Imnaha River is one of Oregon's best kept secrets when it comes to fishing. The lower section of the river (below the Imnaha River Ranch) is very well-known for steelhead. The ranch itself offers abundant opportunities for rainbow trout, bull trout, white fish, and on some years, salmon (buyer to confirm current fishing regulations with Oregon Department of Fish and Wildlife (ODFW)). Whitetail deer, mule deer, and rocky mountain elk are abundant on the ranch which qualifies for up to two Landowner Preference (LOP) tags (Buyer to confirm with ODFW). Other hunting opportunities are black bear, chukar, Hungarian partridge, turkey, rough grouse, blue grouse, Rocky Mountain quail, and predators.

The improvements are well built and maintained throughout the years. A very tastefully designed log home sits on a bluff overlooking the green hay meadows. The 2,601 sq. ft. home consists of two bedrooms, a large sleeping loft, two bathrooms, and a walk-in game cooler. There are also ten other outbuildings consisting of barns, hay and equipment storage, a sop area, and more.

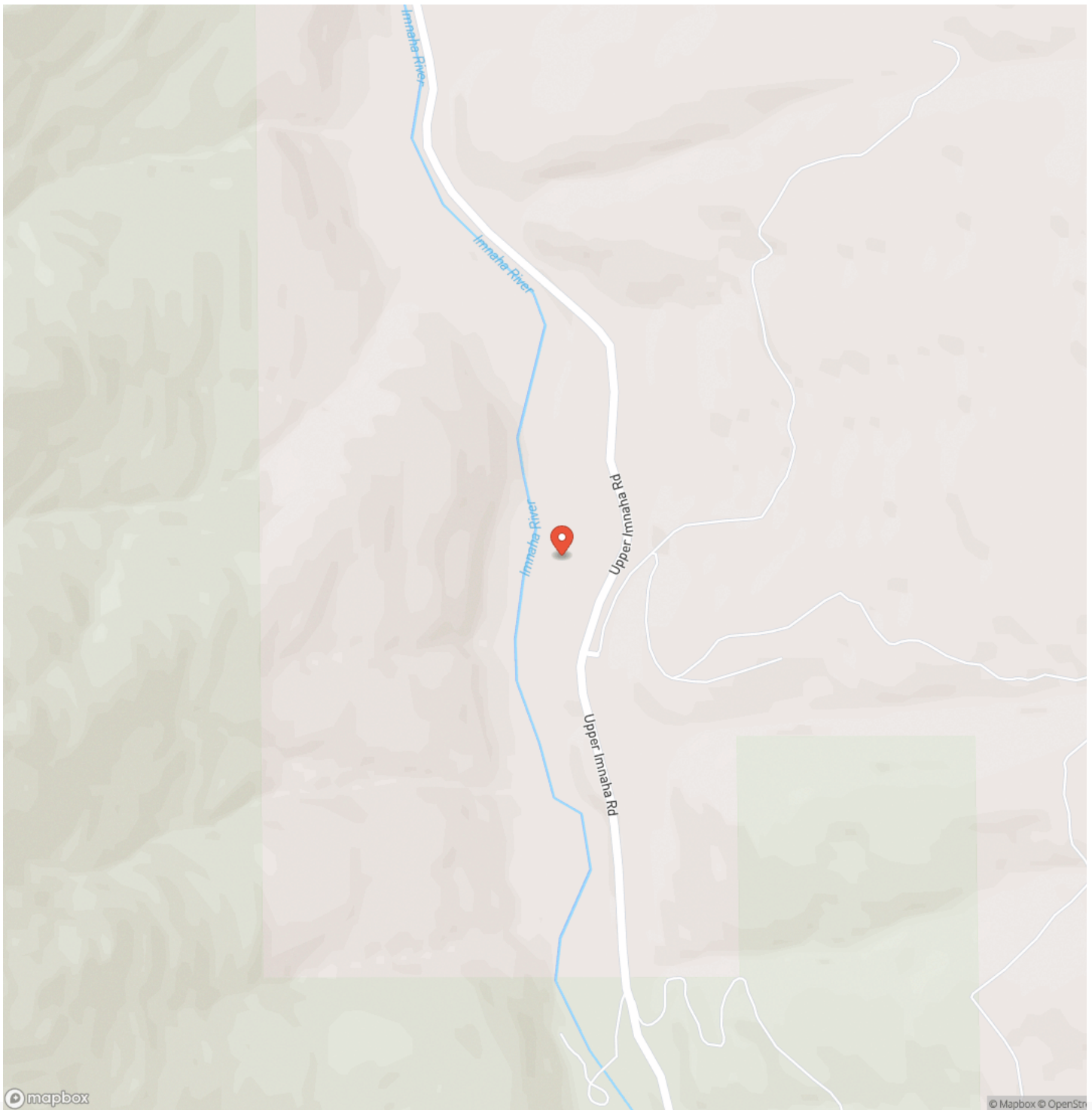

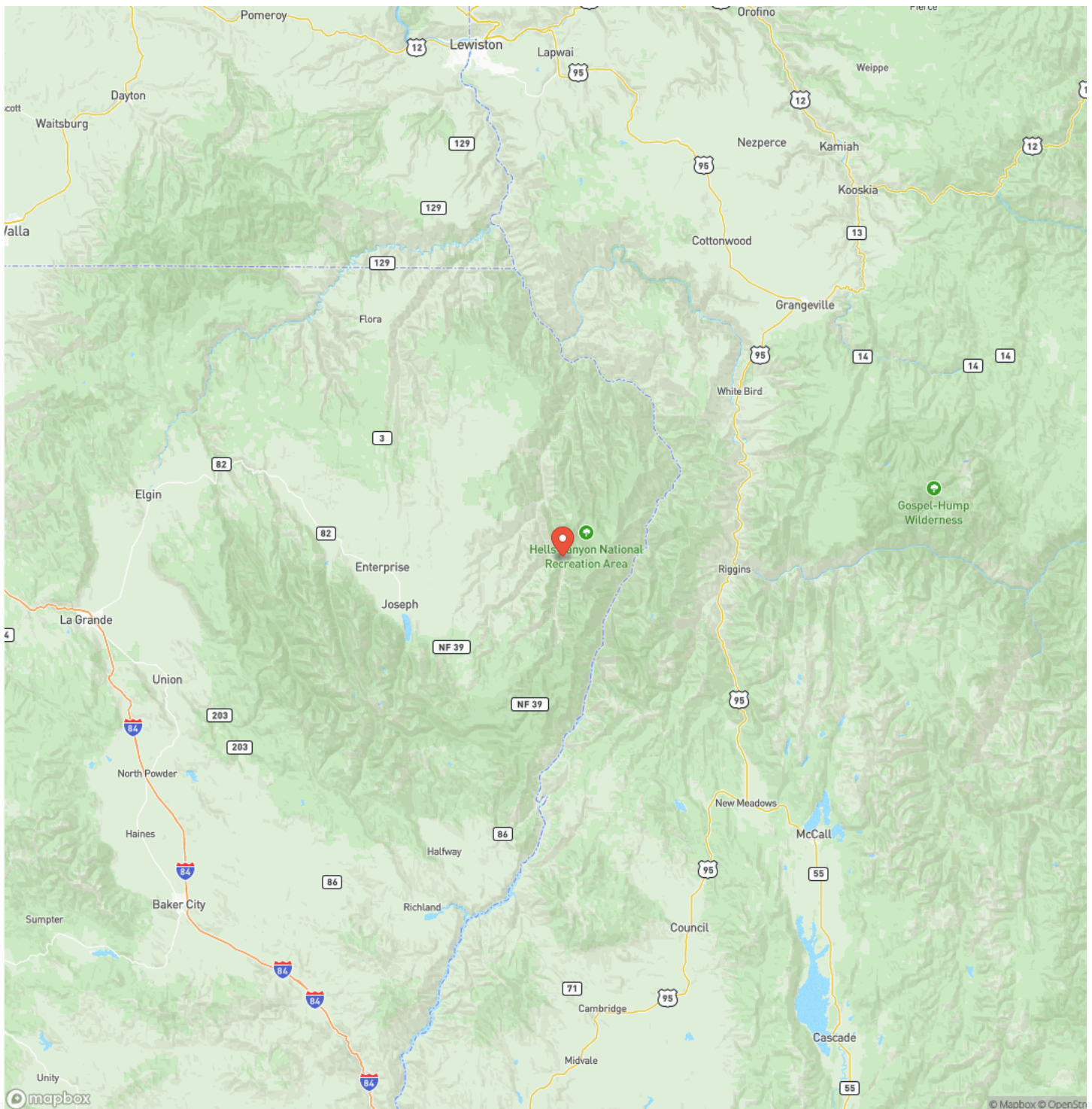
