The Valley place is comprised of 78.8 +- total acres covered under three water right certificates. The property is blended between 49.25 FSA acres of tillable cropland and the remainder in irrigated pasture and improvements. Access is from Lathrop Road, which is only shared with two other homes, and Dagget Lane which makes up the Eastern boundary. Irrigation water is delivered from a mainline pressurized by gravity and flood irrigation through open ditches (no irrigation equipment is included in the sale).

The property includes an 1,863 square foot home with a 336 square foot unfished basement. The home consists of three bedrooms, one bathroom, a mud room and built-in storage. Other improvements include a 1,344 square foot barn, detached 525 square foot garage and four other outbuildings. A small corral system connects to the barn. The improvements sit approximately .5 miles down a gravel road shared by only two other homes giving it a quiet location.

Joseph, OR is a small town only 5.5 +- miles from the property offering many activities throughout the year. Just past Joseph is Wallowa Lake which is known statewide for its size, beauty, and world record kokanee salmon. The surrounding area of Wallowa County offers what seems to be endless opportunities for social events, hunting, fishing, hiking, horseback riding, whitewater rafting. skiing and more. It is very difficult to find a better place to live.
